

# Website Terms and Conditions of Use

# IMPORTANT! PLEASE READ THIS LEGAL STATEMENT CAREFULLY BEFORE USING THE bluescopesteelconnect.com SITE

#### 1. Ownership

The bluescopesteelconnect.com website ("Site") is owned by BlueScope Steel Limited ABN 16 000 011 058.

# 2. Acceptance of Terms and Conditions

- (a) Your access to and use of the Site is conditional upon your acceptance and compliance with the terms, conditions, notices and disclaimers contained in this document and elsewhere on the Site (known collectively as the "Terms and Conditions").
- (b) Your use of and/or continued access to the Site constitutes your agreement to the Terms and Conditions. If you violate any Terms and Conditions your right to use and access the Site automatically terminates.
- (c) BlueScope Steel Limited may amend the Terms and Conditions at any time and with immediate effect by posting the amended terms and conditions on the Site. This agreement may not be amended otherwise. You should visit this page periodically to review the Terms and Conditions.

# 3. Restrictions on Use

- (a) BlueScope Steel Limited may change or discontinue any feature of the Site, including the content, hours of availability and equipment required for access, at any time without notice.
- (b) You may not copy, reproduce, republish, frame, post, upload, distribute, transmit or modify in any way all or any part of the material contained on this Site, unless expressly provided for on the Site or expressly authorised in writing by BlueScope Steel Limited.

    - A. This aggregate information may be disseminated through the Site or provided to third parties. The use of information for these purposes will not identify individual customers; and

- B. BlueScope Steel may disclose information concerning a customer to a third party service provider operating or providing services for the Site on behalf of BlueScope Steel Limited.
- (c) By accessing the Site you consent to BlueScope Steel using and disclosing the information collected from the Site for the Related Purposes.

# 5. Copyright

- (a) The content of this Site, including all information such as text, graphics, images and other material ("Material"), is protected by Australian and international copyright law. Unauthorised use of the Material may violate these copyright laws.
- (b) You may:
  - (i) download a single copy of the Material and where necessary for reference purposes keep a temporary copy in your computer's cache and make a single hard copy of the Material; and

#### 6. Trademarks

- (b) The Trade Practices Act 1974 (Cth) and all corresponding state and territory legislation imply terms, conditions and warranties into some contracts for the supply of goods and services and prohibit the exclusion, restriction and modification of such terms ("Prescribed Terms"). - (c) In addition, BlueScope Steel Limited does not warrant:

  - (ii) that the Site and its servers are free of computer viruses and other harmful data, code, components or other material; or

- (g) To the fullest extent permitted by law, the liability, if any, of BlueScope Steel arising from a breach of the Terms and Conditions or the Prescribed Terms is limited to, at the option of BlueScope Steel Limited
  - (i) in the case of goods, the repair or replacement of the goods; and
  - (ii) in the case of services, the supply of the services again or the payment of the costs of having the services supplied again.
- (h) Other than liability which cannot be lawfully excluded, BlueScope Steel and its respective suppliers, officers, affiliates, directors, shareholders, agents and employees and any third parties mentioned on the Site will not be liable to you or any third party (and whether for breach of contract, tort, for breach of statute or on any other basis) for any loss or damage whatsoever (including any direct, indirect, incidental, special, punitive or consequential loss, loss of anticipated or actual profits, earnings or revenue, loss of business opportunities, loss of data, goodwill or contracts, failure to realise anticipated savings, damages, expenses or costs) resulting from or in connection with, directly or indirectly.:
